Our Policy

Booking and Cancellation Policy

Events creation is a very meticulous process where a million of interdependent things are put together and prior arrangements and planning are made well in advance to ensure the smooth and uninterrupted course of the game, thus:

Bookings made more than 15 business days in advance of the event's date require \$300 DEPOSIT.

The balance is to be paid no later than 15 business days before the event's date.

Bookings made in less than 15 business days before the event's date require a full payment.

A booking is considered accepted with the date and time secured ONLY AFTER a deposit or full payment is cleared.

In case of a cancellation initiated by a customer at any time the deposit amount is NON-REFUNDABLE.

If the weather is not permitting for outdoor activities on the day of the event, we will work with you to find another suitable date and time for your event.

When an event is cancelled by Urban Quest the deposit and the balance payment, if received, are refunded in full.

If the cancellation is initiated by a customer and is less than 48 hours before the event's start time neither deposit nor the payment balance is refundable.

If the cancellation is initiated by a customer and is less than 15 business days before the event's date the payment balance incurs 30% penalty fees.

If the cancellation is initiated by a customer and is more than 15 business days before the event's date the payment balance is refunded in full.

If the number of participants on the day is less than what has been paid for the difference is non-refundable.

Privacy Policy

Introduction

Collection of Information
